1 Open Forum incl. AOB

A member of the public gave his comprehensive evidence of the recent use of the land at Orchard Nurseries including aerial photographs and his objections to 21/02922/CLDE. This included activity on the site during lockdown and his contact with MDDC planning department over the past 18 months. He has supplied the clerk with the photographs and information which has been circulated to the Councillors. The Council discussed the application under 11.1 below.

4 Minutes

Council unanimously **RESOLVED** to approve the minutes of the meeting held on Monday 10th January 2022 as true & correct record. The Chairman duly signed them.

6 Reports of County and District Councillors.

6.1 Devon County Council

Cllr Connett discussed the Highways issues in Matters Arising above and offered his help. He advised that the new speed limit signs were due to be installed in March.

Cllr Connett also advised that the PCC Commissioner was matching funding for speed-activated warning signs for which Whitestone and Exminster parishes were applying. Kenton have already secured the grant.

6.2 Teignbridge District Council

Cllr Swain advised the following:

- The Midas group going into receivership has delayed TDC's decarbonisation project, but only by a couple of weeks. Another contractor has already been appointed.
- Strong objections were being raised for the housing proposed at Markham's farm, supporting the campaign by Cllr Foden.
- Further strong objections are being made on the landfill proposals that are near Longdown but not in the Parish. Cllr Swain said that there didn't need to be so much landfill capacity concentrated in the small area proposed as they are quite close together and to existing sites (Kennford, Whitestone & Trood Lane).
- The activity at the A30 Alphington junction is unauthorised and is being dealt with.
- He has a Community Fund able to grant small amounts (£1-200) to community groups.

When asked about the graffiti on the bridge at Baker's Hill he thought that Ide would probably support Cllr Morley's suggestion for a nature mural.

7.3 Queen's Green Canopy and the Platinum Jubilee in 2022

The Council congratulated Cllr Morley on a splendid job organising the trees and creating an excellent certificate. Cllr Morley advised that:

- 57 trees have been supplied to residents.
- One tree for the Church has been agreed.
- A Tree Passport, Risk Assessment & Insurance had been sent to the Woodland Trust for Cutteridge Wood and permission has been obtained to plant there.
- She hopes that the community will have a get-together for the Church and Village Hall treeplantings with a walk between the two and refreshments.
- The Woodland Trust will promote the plantings and a large tree is available from Devon Wildlife Trust.
- Everyone who plants a tree is encouraged to upload their photos to the official QGC website (instructions on the certificate – use 'broadleaf' as the tree type on the dropdown menu). It is possible that Holcombe Burnell could be the first Parish in the country to register 70 trees planted.

10 Reports

10.1 Clerk's Report – The clerk reported the following:

- Amanda from Precepts@teignbridge.gov.uk emailed for confirmation of the precept requested and a justification for the increase of 49.96%. Although there was no job title identified the clerk replied with the reasons from the Parish News for the Tedburn Times and correcting her calculations to the 47.28% (or 78p/calendar month/Band D household)
- The Citizen's Advice Bureau had supplied figures for the latest quarter. They have helped 2 clients from Holcombe Burnell with 19 issues.
- Stagecoach have reduced the frequency of some bus services in and around Exeter. While
 the service to Longdown remains the same anyone connecting with other services in Exeter
 is advised to check the new timetables.
- DCC has been awarded £2.76 million for four projects, including grant activity to support
 diversification in the agricultural sector, support for the development of digital skills among
 harder to reach communities, a delegated grant programme to support business innovation
 among small businesses in Devon, and additional support to assist those with a disability to
 access employment. If this applies to any resident the clerk will help with access.
